Mr. Nilotpal Roy (DIN 00087298) was appointed as a Non-Executive Independent Director of the Company in terms of Section 149, 152 read with Schedule IV and other applicable provisions of the Companies Act, 2013 ('the Act') for a period of five years effective from February 14, 2020 by the Members of the Company at the 57th Annual General Meeting of the Company held on December 22, 2020. His first term as an Independent Director shall expire on February 13, 2025.

In terms of the Regulation 17(1A) of SEBI Listing Regulations, consent of the members by way of special resolution is required for appointment or continuation of Directorship of a Non-Executive Director, beyond the age of 75 Years.

Mr. Roy had attained the age of 75 years on January 13, 2023 and approval of the Members are required for continuation of his directorship from the day he attained the age of 75 years till expiry of his current term i.e., till February 13, 2025.
