Sub: Waiver /Exemption Request Letter as per the Policy for exemption of fines levied as per the provisions of SEBI SOP Circular (Reasons for waiver/reduction of penalty levied under SEBI SOP circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020.

With respect to the above-mentioned subject, we would like to inform you that the Company was recently not in a position to comply with Regulations 17, 18, 19, 20 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), due to impossibility of compliance arising out of Court/Regulatory directions as explained below:

- (1) Pursuant to the Hon'ble National Company Law Tribunal ("NCLT") Order dated April 29, 2022 the Company ("corporate debtor") was admitted to Corporate Insolvency Resolution Process ("CIRP Process") under Section 7 of the Insolvency and Bankruptcy Code 2016 ("Insolvency Code"). The powers of the Company's Board of Directors had since remained suspended, its function being vested with Interim Resolution Professional/Resolution Professional, as applicable, until completion of the Process.
- (2) Reference is also drawn to sub-regulation (2A) and (2B) of Regulation 15 of the Listing Regulations granting exemption from compliance with Regulations 17, 18, 19, 20 and 21 to a listed entity during the insolvency resolution process period, provided the roles and responsibilities of its Board of Directors and committees thereof are fulfilled by the Interim Resolution Professional/Resolution Professional in accordance with section 17 to 23 of the Insolvency Code.
